 - As co-lead counsel, represented parents and children from 21 school districts in the *Lobato v. State* of Colorado school finance litigation. (2007-2013) *Lobato* was a challenge to the constitutionality of the school finance system in Colorado. It involved two appeals to the Colorado Supreme Court, extensive discovery, and a 5-week trial in Denver District Court. Directed all aspects of the litigation, including over 30 attorneys, paralegals and legal interns. Retained and worked with national experts in multiple areas including teacher quality, special education, school finance, impact of poverty on students, and the importance of pre-school education. Retained and worked with 14 amicus parties and counsel.
 - Co-lead counsel for Giardino v. State of Colorado class action litigation.
 (1998 2008Ele)
 Giardino involved a challenge to the constitutionality of funding for facilities in Colorado. The case settled in May 2000. Led school tours in rural Colorado with elected officials, including Speaker Andrew Romanoff and State Treasurer Cary Kennedy. Tours led to establishment of BEST legislation (Building Excellent Schools Today) in 2008. BEST has funded over \$2.5 billion in facilities throughout Colorado to date.
- <u>University of Denver College of Law Adjunct Professor</u>, 2014 Present Education Law. This is a survey class of major educational legal issues, covering such topics as race-conscious remedies, campus safety and criminal justice, rights of educators, bilingual education, privacy law, religion in the schools, LGBTQ- related issues, ESEA flexibility.
