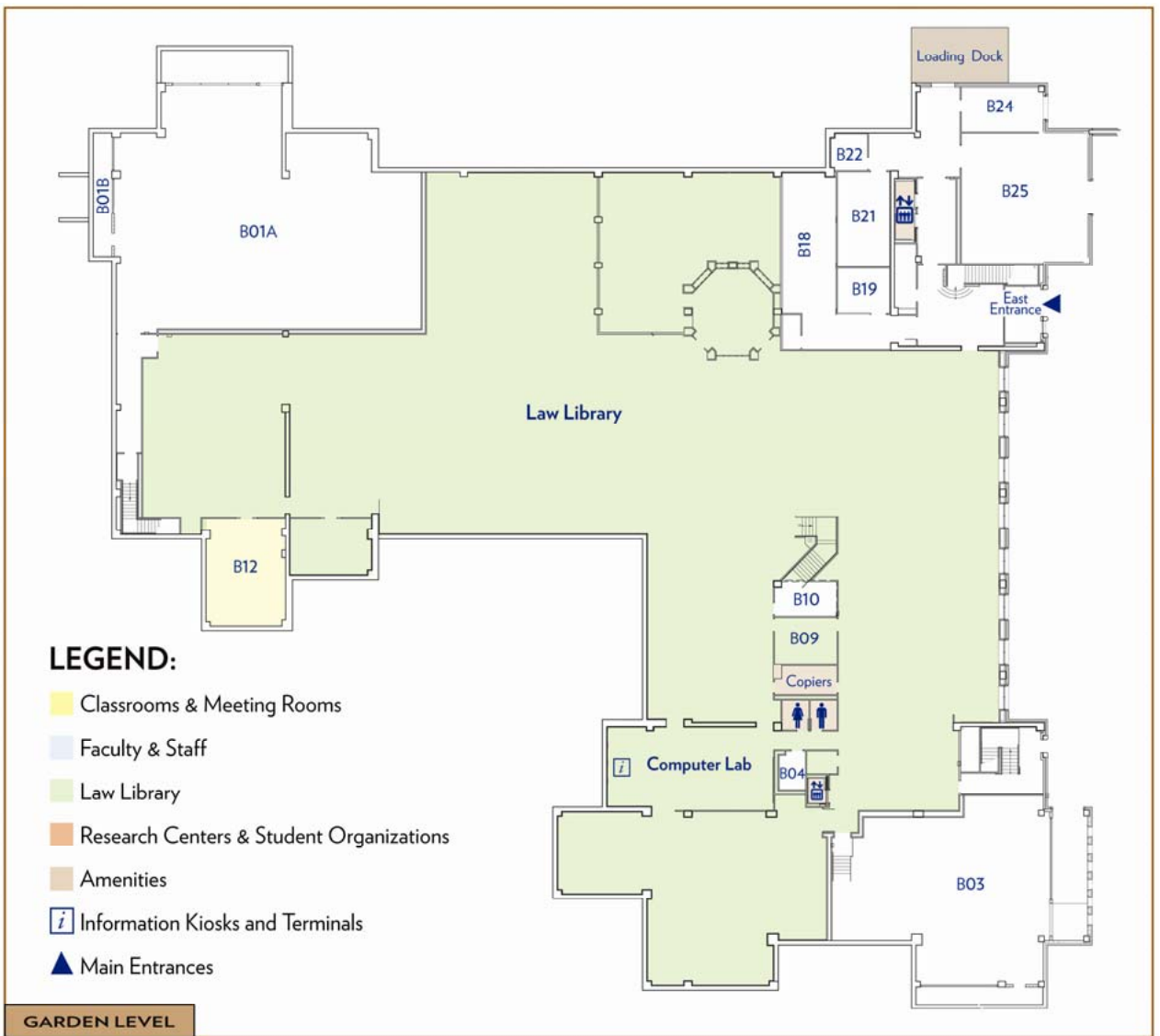
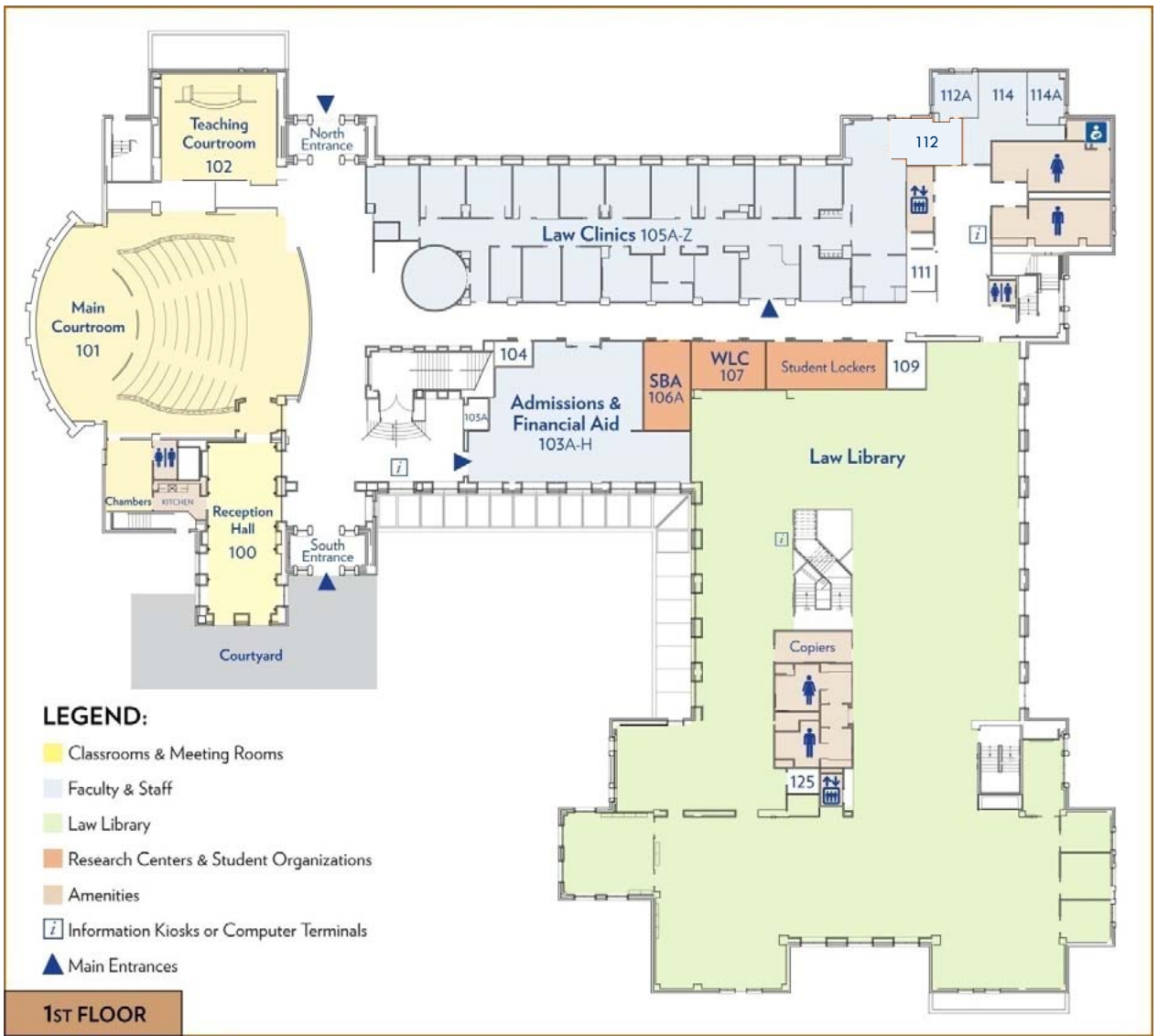
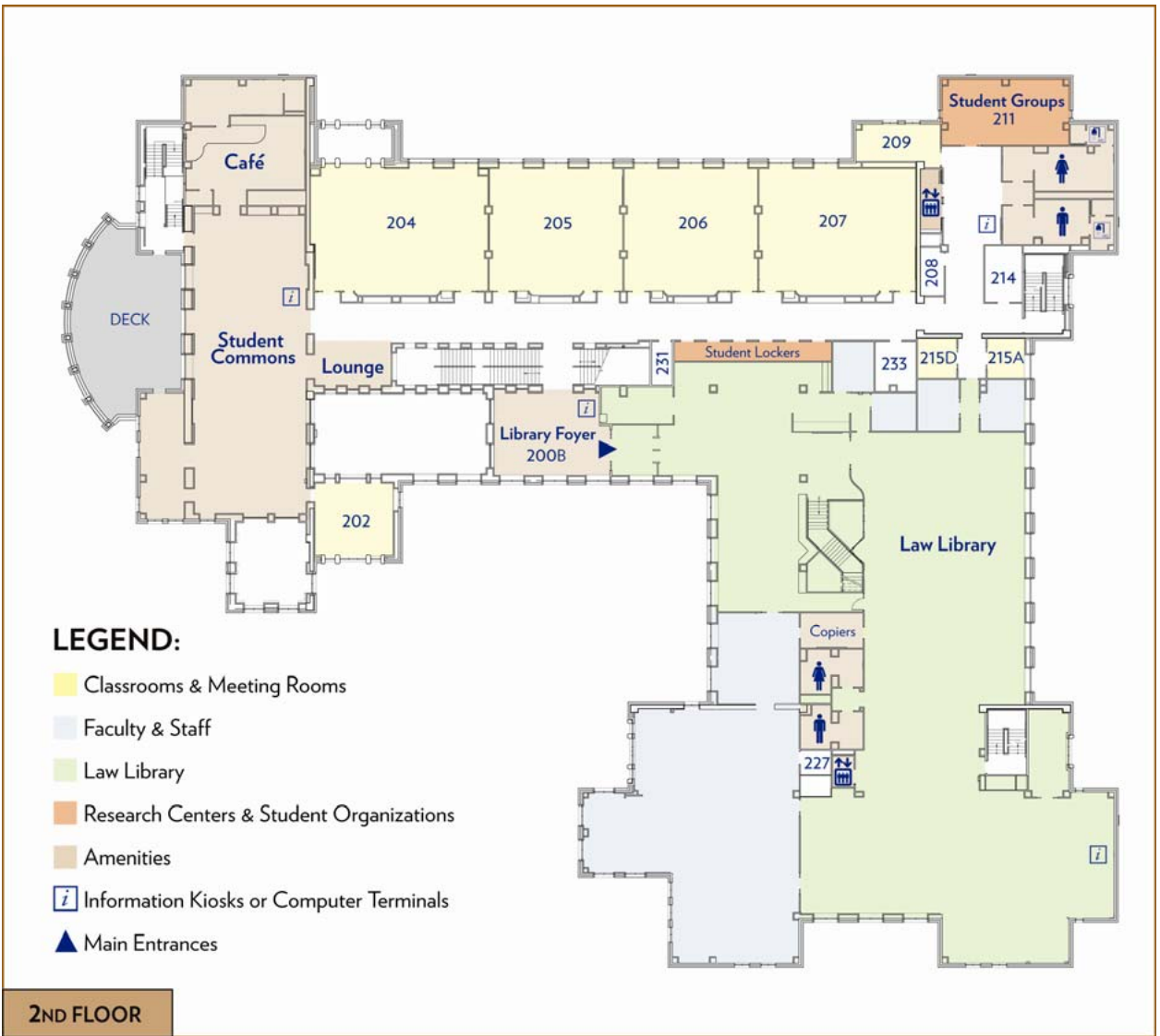


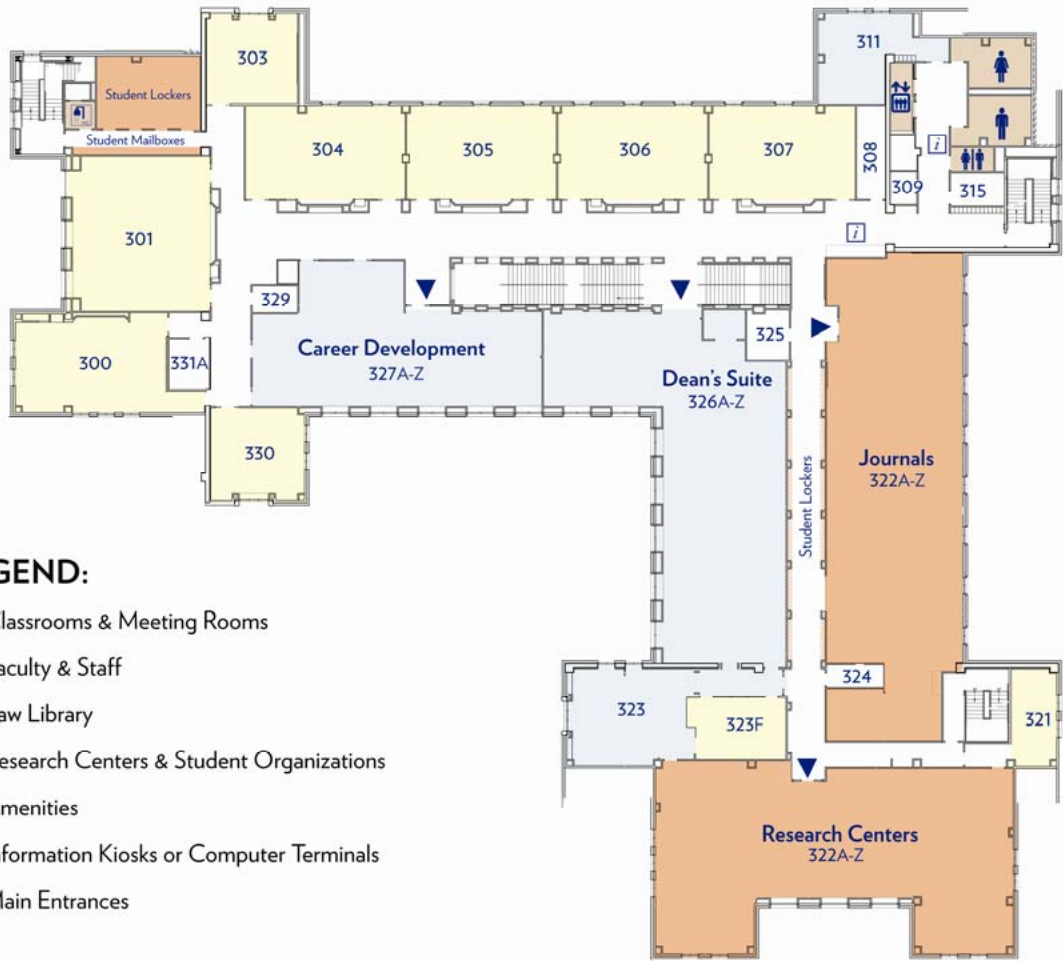
WOLF LAW BUILDING MAP





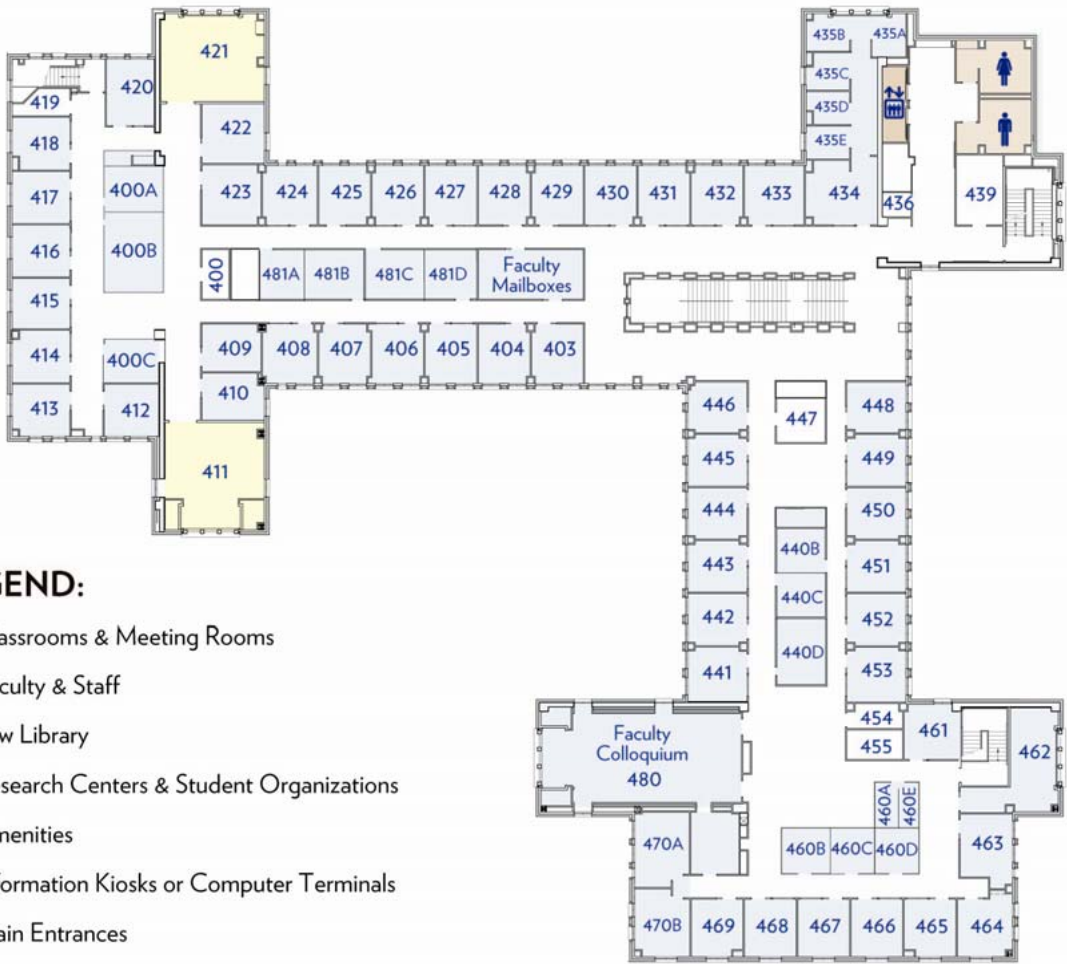






3RD FLOOR
