ADMINISTRATIVE LAW SYLLABUS

Readings. The casebook is Cass, Diver, Beerman & Freeman, Administrative Law (Aspen, 6th ed. 2011). As the assignments listed below indicate, we will cover most of the book at a pace of about 50 pages a week. Please stay with the assigned pace unless I notify you otherwise; I will speed up and slow down a bit depending on the importance of the material, but within the overall pace of the course. The course will cover federal administrative law principles. State administrative law derives from these principles, with variations that I will mention as needed.

Reference books. For helpful guidance, I recommend (but do not assign) the following: Fox, Understanding Administrative Law (Lexis, 5th ed. 2008); Pierce, Shapiro & Verkuil, Administrative Law and Process (Foundation, 5th ed. 2009); and for essays, Schuck, Foundations of Administrative Law (Foundation, 2d ed. 2004).
