ADVANCED INDIAN LAW SEMINAR: CRIMINAL AND CIVIL JUSTICE IN INDIAN COUNTRY

Professor Troy A. Eid University of Colorado School of Law Fall 2012

COURSE DESCRIPTION: The U.S. Constitution recognizes three distinct sources of sovereign authority within the United States: the federal government, the several states, and Indian tribes and nations. This course explores the ability of tribes "to make their own laws and be governed by them," *Williams v. Lee*, 358 U.S. 217, 220 (1959), within our federal constitutional system. We will examine the interplay among the three sovereigns through a series of "hot topic" presentations by distinguished guest lecturers, including practical problems and case studies dealing with criminal and civil justice issues.

COURSE PAPER: All students must complete a substantial piece of writing that meets the course requirements (approximately 30-40 pages). Proposed paper topics must be submitted in the form of a concise written outline submitted to Professor Eid for comment and approval on or before Thursday, October 25th. Draft papers are due Thursday, November 29th. During the final classes, students will present and discuss their draft papers for the benefit of the entire group.

PAPER DEADLINE: THE DEADLINE FOR ALL COMPLETED COURSE PAPERS IS THURSDAY, DECEMBER 13th, at 5:00 pm Mountain Time.

COURSE GRADING: The paper will count for 75 percent of the student's final grade. The remaining 25 percent will be based on class participation.
