ADVANCED TRIAL ADVOCACY FALL 2012 SYLLABUS

Thursdays, 6:05 – 7:45 p.m., Room 301

This course is intended to teach additional trial skills for those students interested in trial practice. The emphasis will be almost entirely on civil trials, although the skills learned will be useful in criminal trials as well. The course will focus on practice exercises and will seek to hone and add to the skills you learned in the basic class. If you took my basic trial advocacy class, some of the exercises may be familiar to you, and I will endeavor to find different exercises so as to avoid repetition.

August 30	Introductions
	Be prepared to teach the class something (anything) for 10 minutes.
September 6	F.R.E. Lightning Round
	Getting Evidence In and Overcoming Objections
	Read Mauet §§ 6.1-6.3
	Familiarize yourself with the <i>Flightworthy</i> problem (posted on the TWEN site) and be prepared to get any of the exhibits admitted. Also be prepared to object to the admission of any exhibit.

Date	Assignment
September 13	Depositions
	Read Mauet Section II: "Do it Yourself Guide to Taking Depositions"; and "Defending Depositions." These two papers will be posted on the TWEN site. They are old, but still relevant. Familiarize yourself with the current versions of the rules cited in the papers.
	Read the background material on the practice case (also posted) and be prepared to take (and defend) a short deposition of L. Phipps.
September 20	Depositions (cont.'d)
	Deposition critique
	Read Mauet Section 7.7.
	Review your deposition transcript and prepare a cross examination based on that transcript. Be prepared to impeach the witness using the transcript when he changes his testimony.
September 27	Voir Dire
	Read Mauet Chapter III.
	Be prepared to choose a jury <i>Myrick v. Mission Viejo</i> (this is the same case that was used for the deposition exercise).
	Students will be assigned to either plaintiff or defense teams.
	Each of you MUST bring TWO people to class to act as jurors for this exercise
October 4	Critique of Voir Dire
	Deposition Impeachment (continued, if necessary).

October 11	Opening Statements
	Read Mauet Chapter IV.
	Read one of several articles concerning a current legal issue. Choose one article and prepare an opening statement based on the article's facts.
October 18	Objections and Evidence Refresher (no reading assignment)
October 25	Direct and Cross Examination Drills by a surprise guest-speaker. Skim Mauet Chapters V (Sections 5.1 – 5.3) and VII (Sections 7.1 – 7.6 and 7.8).
November 1	Experts: Review <i>Jerry's Wiring</i> problem (to be posted). Read Mauet Chapter VIII.
	Be prepared to conduct a direct or cross examination of Plaintiff's expert. (Students will be assigned to plaintiff or defense side.)
November 8	Trial Graphics
	Read Mauet Section 6.4. Nicole Rullet of Z-Axis will make a presentation showing you the latest available technology in trial graphics.
