Biography

Natalie Hanlon Leh is an experienced intellectual property lawyer who serves as lead counsel in patent, copyright, trademark and trade secrets matters. As part of Ms. Hanlon Leh's litigation practice, she represents clients in a wide range of technologies, including chemistry assays, genetic research methods, software, cloud storage, fiber-optic networks, tunable lasers and erbium doped fiber amplifiers. Ms. Hanlon Leh has substantial experience with injunctions and expedited proceedings. Since 2004, she has served as an adjunct professor at the University of Colorado School of Law, where she teaches patent litigation.

Prior to joining WilmerHale, Ms. Hanlon Leh was a senior trial lawyer focusing on complex intellectual property matters and national practice group leader in another firm's Denver office.
